- o Call out for submissions for next article due start week 10
- More constitutional reform
- Attendance policy clarification
 - Wasn't clear during handover, so it took a while to understand obligations
 - Will upload document tonight clarifying
 - Warning system in place, will be contacted if you have a warning
 - Warning if you hit 3 explained absences
 - Running attendance document in the Important Documents folder
 - Yellow = explained absence
 - If you're consistently missing meetings we want to check in and make sure you're ok
 - Warning if unexplained absence (if you don't tell anyone you'll be absent)
 - Reasoning is that the Exec has disciplinary powers under the constitution (very broad)
 - Unacceptable behaviour (e.g. bullying or harassment) can result in disciplinary action
 - Q: warning if late to meeting?
