Wellbeing:

- Law Mental Health Week is in Week 10
- Working with CoL Wellbeing Initiative staff and student MH wellness
- o JD Committee passed a mental health provision now a mandatory consideration
- Exec needs people to be engaged talk to your VPs if you have ideas/feel over or under-used etc.

Discussion of Proposal: delivery of sexual assault content in LAWS1206

- o Em disclaimer and welcome
- o Ella was meant to come but she can't now, so Bryce will present
- Unit presented in Week 9
 - Mandatory part of education
 - Important part of education especially if you're going to practice criminal law
 - Specially effects survivors very different for people who have experienced it

At ANU

- Lecturers are understanding
- Flagged the week in advance and provide themselves as there to talk
- Don't know how much it works
- Last year's exam had a very visual question on Sexual Assault
- The course does not change
- The content of the course doesn't change
- Now an alternative for people the current system doesn't suit/work for
- o Rather than going to lectures, people have another option (seminar)
 - Resources are right outside the door
 - Teachers are aware of the situation
 - Teaching style better for these people
- o Bryce's reservation is that the Convenors must be on board they are talking this week
- o Ella is keen to hear feedback there is still time to amend it
 - Mickey: concerned with "later year law students who have survived sexual assault" and whether those people could be not prepared to talk about it/mental health training
 - Maddison: people's experiences are very different and can be ineffective to recommend things if they won't work for a survivor's experience
 - Campbell: is the idea with peer support so that they are there to gauge whether the content is effectively being delivered?
 - Bryce: to what extent are the peer involved in the teaching and learning process? He hasn't had a lot of time to engage in the proposal
 - Em: similar concern CRCC run an "introductory crash course" on how to deal with sexual assault the peer support shouldn't be counselling we need some clarity
 - Bryce: no one is forced to attend
 - Lucy: not sure how turnout would go re revealing that you are a survivor
 - Em: the way autonomous spaces are made safe is the "don't ask don't tell" mantra can be empowering for some students comes down to the people who run it
 - Bryce: being separated for the cohort attendance would not be pubic or known to anyone who was not there
 - Maddison: not attending the tutorial that week (and attending the seminar instead) might out people as survivors anyway
 - Campbell: presentations in Week 9, so sexual assault tutorial should be in Week
 10
 - Lily: what about the exam questions?
 - Bryce: possibly changing the exam format, give extra options, maybe separate rooms – already can apply for special conditions in exams
 - Em: Access and Inclusion organises special conditions but can be very difficult to organise maybe they should work together to organise separate rooms?
 - Bryce: they should not remove the sexual assault content from the exam content altogether
 - Mickey: loop in Amelia and Wayne because they can get onto A&I straight away
 - Suchara: they don't need to tie in sexual assault question with another topic in the exam question

- Bede: was there a warning on the 2016 final exam question which described a sexual assault? Answer: no, but there should have been
- Suchara: LSS and Library past exam databases have sexual assault answers (Eden to address LSS database issue)
- Kathy: can they print the questions in separate papers with the warning on one paper so people don't even have to open that question booklet if they are uncomfortable with the idea of answering a sexual assault question?
- Lucy: the mid-semester exam is redeemable but you have to do both questions in the final
- Em: have a Q2 a) and b) one of which does not address sexual assault
- o How do we engage people?
 - Stalkerspace = no
 - Women's Department = maybe through Holly but block comments?
 - Convenors Wattle forum post?
 - Campbell: not everyone engages with Wattle posts
 - Lucy: administrative announcements before lecture
 - Kathy: content warning should be made during Week 9
 - Em: CRCC's number and 1800 RESPECT's number on the first slide
 - Shani: never did content warnings after the Week 9 lecture for revision lectures
 etc
 - Shiban: warnings on reading lists?
 - Em: Lifeline's number on the Wattle page at all times
 - Anna: other content could be distressing for people, not just sexual assault, so the general Lifeline number should definitely be there
