- o Solution to removing exam database
 - Assuring students that there are resources being provided by CoL which are just as good, if not better
- ALSA Conference:
 - In Canberra this Winter discussing issues which LSS' face around the country
 - July Conference competitions happen throughout the week
 - Bryce and Eden went
 - Big topics of discussion:
 - Increasing Indigenous content in legal education (not required in priestly eleven) – comparing Course Guides for property law in particular

 - LSS' will need to look how we implement those targets

 - Pushing to update disclosure guidelines before admission to practice
 - Test concerned with health condition affecting ability to practice
 - Physical and mental health conditions are treated one and the same you only have to disclose if it will affect your ability to practice
 - Action items:
 - President mostly about Sponsorship etc.
 - Admin will discuss with Julia and Hugo individually
 - Finance Xero v MYOB discussion will be had
 - Events equity tickets discussion will be had
 - Comps will talk to team about topics, some very interesting
 - SJ no items, but will be involved with Equity portfolio restructure
 - Careers talked about items, but would have to re-work ideas because of limited number of law firm sponsors in Canberra
 - Education Equity portfolio largest topic, things which ALSA wants Bryce and Eden to do
